Frequently Asked Questions (FAQs) for Prospective Students Applying for the Four-Year Undergraduate Programme (FYUGP) at Govt. College for Women, M.A Road Srinagar for the Academic Session 2024-25:

- Q1.** How do I register for the Four-Year Undergraduate Programme (FYUGP) at Govt. College for Women, M.A Road Srinagar?
To apply for any programme, both CUET and Non-CUET candidates must register @ <https://jkadmission.samarth.ac.in> and complete the requisite steps.
- Q2.** How is the eligibility for a particular programme determined at GCW M.A Road Srinagar?
The eligibility of a particular programme is determined by the subjects at the 10+2 level and the CUET paper in which an aspirant has to appear for CUET-2024 and the same is available @ <https://jkadmission.samarth.ac.in/index.php/site/prospectus> or <https://www.gcwmaroad.edu.in/admissions.php>.
- Q3.** How do I select my preferred programme(s) during the application process?
Log in to your account at <https://jkadmission.samarth.ac.in>. Click on Apply CUET-Based Preferences and select Govt. College for Women, M.A Road Srinagar. The system will display all the preferences (subjects) for which the candidate is eligible to apply for admission. Select the subject(s) of your choice in order of preference. If a particular programme is not displayed, it means the candidate does not meet the requisite eligibility for the course, which can be cross-checked with the eligibility rules. In this case, the candidate needs to apply for Non-CUET-based preferences for their desired subject.
- Q4.** I have appeared in CUET-2024 but cannot find a suitable subject among the CUET preference options for GCW M.A Road Srinagar?
If a particular programme (Subject) is not listed, it means the candidate does not meet the requisite eligibility for the course. The probable reason could be not appearing in the CUET-24 General Test, which is mandatory for all courses from CUS. Therefore, you need to apply for Non-CUET-based preferences for your desired subject.
- Q5.** Can I rearrange my programme preferences after submitting the application?
Yes, candidates can arrange their preferences according to their best choices even after submission of the application.
- Q6.** I have completed the registration and Programme Preference Selection (choice filling). What should I do next?
Wait for the CUET and Non CUET Seat allocation Lists which shall be notified after **14-08-2024** @ <https://jkadmission.samarth.ac.in> & <https://www.gcwmaroad.edu.in/admissions.php>
- Q7.** What are the next steps after the Merit List / seat allocation lists are published?
Visit Govt. College for Women, M.A Road Srinagar, as per the notified schedule, available at <https://www.gcwmaroad.edu.in/admissions.php>, to choose your other allied subjects and deposit the requisite admission fee.
- Q8.** I cannot find my name in the first round of seat allocation. What should I do?
Wait for the next merit list/seat allocation round and adjust (if needed) the order of your preferred subjects based on the cutoff of the previous round for your most preferred subject.
